# STUDENT RIGHT TO KNOW, CAMPUS SECURITY, AND COMPLIANCE REPORT

## Includes the 2010 Crime Awareness Report for the MCC Campuses

The Student Right to Know, Campus Security, and Compliance Report is published on an annual basis and includes information which is of interest to current and prospective students and employees of Metropolitan Community College (MCC). The report includes the following sections:

**Crime Awareness Report** - contains information about security issues at the campuses. Major issues include:

How to report a crime - location, office hours, and phone numbers for the MCC Campus Police Department as well as information on crime reporting.

Timely warning policy - how and when Campus Safety Alerts are issued.

Emergency response and evacuation procedures - procedures to respond to significant emergency or dangerous situations.

About public safety - information about MCC's Campus Police Department.

Access to buildings - hours of access to MCC buildings

Security of campus facilities - description of MCC's efforts to maintain safety and security of buildings and grounds.

Security services - special safety and security services provided by the Campus Police Department.

Education and awareness - description of MCC's crime prevention and awareness programs and procedures.

Sexual assault policy - information on MCC's policies to counter sexual assault.

Registered sex offenders information - where to obtain a list of registered sex offenders.

Relationship with local law enforcement - information on MCC's relationship with state and local law enforcement agencies.

Definitions of crimes - the definitions MCC uses to classify reported crimes.

Crime statistics - information identifying the occurrence of criminal offenses and number of arrests for crimes occurring on campus and adjacent public property over the last three calendar years. The section also includes the number of arrests and disciplinary referrals for liquor law violations, drug abuse violations, and weapons possessions. Safety Tips - includes important information regarding personal safety.

**Compliance Information** - contains MCC's Notice of Nondiscrimination and Access Notice (for students with disabilities), as well as information on policies regarding discrimination and harassment including sexual harassment, the Family Educational Rights and Privacy Act (FERPA), copyright infringement, and Tobacco-Free MCC. It also contains information on how to obtain MCC graduation, transfer, and retention rates, Equity in Athletics Disclosure Act (EADA) data, graduate placement information, and student consumer information. Additionally, it includes MCC's complaint notification.

**Drug-Free Workplace, Campus, and Community** - contains information on MCC's policies regarding the possession, use, and sale of alcoholic beverages and illegal drugs, the enforcement of Federal and State drug laws, and the enforcement of State underage drinking laws. It also contains information on the uses and effects of drugs of abuse, Federal drug trafficking penalties, and Federal penalties and sanctions for illegal possession of a controlled substance. Information on MCC's educational program on drug and alcohol abuse is described.

**Students Who Have Received Athletically-Related Student Aid** - lists the number of students, by gender and ethnicity, who received athletically related student aid. The numbers are listed by college and sport. Information is available for the 2009-2010 and 2010-2011 academic years. Unduplicated headcount by gender and ethnicity is also listed for each college.

# CRIME AWARENESS REPORT

---

## You have the right to know.

You should know how safe your college is. That's why the "Crime Awareness and Campus Security Act of 1990" and its subsequent amendments were enacted.

One of the provisions of this act requires institutions of higher learning to provide a security report which contains information identifying the occurrence of criminal offenses and number of arrests for crimes occurring on campus and adjacent public property. The report also contains information on the number of arrests and disciplinary referrals for liquor law violations, drug abuse violations, and weapons possessions. This report provides that information for the last three calendar years both for the Metropolitan Community College District (MCC) as well as for each individual campus. It also provides information for prevention and reporting of crimes.

Every year, MCC also reports these crime statistics to the Office of Postsecondary Education of the U.S. Department of Education. Reported criminal offenses for over 6000 colleges and universities in the United States are reported on the OPE Campus Security Statistics Website located at <http://ope.ed.gov/security>.

## How to report a crime.

**Crimes, including sex offenses, which occur on campus should be reported to your Campus Police Department as soon as possible. You may contact your Campus Police Department or the Control Center at (816) 604-1200 24/7.**

**MCC-Penn Valley/Pioneer** - Located on the second floor Room 239A. Hours are from 7:00 a.m. to 8:00 p.m. Monday through Thursday, 7:00 a.m. to 6:00 p.m. Friday, and 8:00 a.m. to 4:00 p.m. Saturday. **Call (816) 604-5023.**

**Chief of Campus Police** - Located at 1601 Prospect Ave., Kansas City, MO. Hours are from 8:00 a.m. to 4:30 p.m. Monday through Friday. **Call (816) 604-1453**

**Associate Director of Campus Police** - Located at 1601 Prospect Ave., Kansas City, MO. Hours are from 8:00 a.m. to 4:30 p.m. Monday through Friday. **Call (816) 604-1370.**

Report a crime to the Campus Police officer on duty. If there is no Campus Police department, report the crime to the college official in charge.

As far as satellite "campuses" are concerned, MCC has no authorized Campus Police organization. These facilities are protected by local law enforcement agencies. In case of an incident, contact the local police, then report the crime to the college official in charge.

If you do not wish to come to the Campus Police office to make the report, department personnel will come to you.

The Campus Police officer or official will assess the situation to determine if there is a need to contact emergency medical personnel or the local police. **In an emergency, you can make a walk-in report to the nearest police station and then report the crime to campus authorities.**

The Campus Police officer will prepare an MCC report even if a separate report is taken by the local police.

## Your report is vital.

Reporting crime to campus authorities and local authorities is very important to your college and your fellow students or employees. It not only helps college and local authorities apprehend those responsible, but also helps provide an accurate picture of the amount of crime on campus so it can be determined what additional steps may need to be taken.

Your report will also help the college determine if disciplinary action is required. In addition, your report may be crucial for timely emergency procedures such as evacuation of buildings (you should familiarize yourself with the emergency procedures outlined in your student or employee handbook).

## **Timely warning policy.**

In the event a situation arises, either on or off campus, that in the judgment of the MCC Chief of Police or Chancellor constitutes an ongoing or continuing threat, a campus-wide "timely warning" will be issued. The warning will be issued through MCC's e-mail system to its students and employees.

Depending on the particular circumstances of the crime, especially in all situations that could pose an immediate threat to the community and individuals, the MCC Police may also post a notice on the MCC main website providing the MCC community with more immediate notification. In such instances, text messages will be transmitted to those who have opted into the text messaging system.

Anyone with information warranting a timely warning should report the circumstances to the MCC Police at (816) 604-1200.

## **Emergency response and evacuation procedures**

MCC is committed to provide quick response to emergency situations and to notify the community on the proper procedures to follow. Once a significant emergency or dangerous situation involving an immediate threat to the health or safety of the students or employees is confirmed by Campus Police and MCC Administration, members of the campus community will be notified without delay. This disseminating of information will be done through e-mail, posting on the MCC website, text messaging and the integrated fire alarm system.

The integrated fire alarm system includes an intelligent notification throughout the MCC District. It provides a means for pre-recorded messages to be announced at a single building, an entire campus, or at all campuses during fire, storm, or lockdown or other emergency situations. The messages can either be initiated at an individual campus or at the MCC district Campus Police control center.

Located throughout each facility are evacuation maps showing the location and the proper routes to use in the event of a fire or tornado. The evacuation maps also include the contact numbers to the Campus Police department at that location. Each location conducts an annual test of the integrated fire system along with drills or information sessions on emergency procedures.

In the event of an actual emergency, the MCC community will be notified through their e-mail and the MCC website. Text messages will be transmitted to those who have opted into the text messaging system. Students should take the responsibility for regularly checking their assigned student e-mail accounts.

## **About public safety**

The MCC Campus Police Department has commissioned law enforcement officers.

MCC Police have the complete authority to apprehend and arrest anyone involved in illegal acts on campus and in areas immediately adjacent to the campus. If minor offenses involving MCC rules and regulations are committed by MCC students, the MCC Police may also refer the individual for disciplinary action consistent with the Code of Student Conduct.

By mutual agreement, the Campus Police maintain an NLETS terminal (National Law Enforcement Telecommunications Network). Through this system police personnel can access the National Crime Information computer system. The computer database is used for accessing criminal history and data including driver and vehicle identification information.

**It is very important that you report crime to campus authorities to ensure a safe and secure campus environment.**

## **Access to buildings.**

One of the most important methods to control crime is to control building access. For that reason, access to campus buildings is limited to certain hours of the day, and all facilities are monitored.

Here are the building hours for the campuses:

**MCC-Business & Technology** - 7:00 a.m. to 10:00 p.m., Monday through Thursday, and 7:00 a.m. to 6:30 p.m. on Friday.

**MCC-Facility Services Building** - 8:00 a.m. to 4:30 p.m., Monday through Friday.

**MCC-Longview** - 7:00 a.m. to 10:00 p.m., Monday through Thursday, 7:00 a.m. to 6:00 p.m. on Friday, and 7:30 a.m. to 3:00 p.m. on Saturday.

**MCC-Maple Woods** - 7:00 a.m. to 10:00 p.m., Monday through Thursday, and 7:00 a.m. to 5:00 p.m. on Friday and Saturday.

**MCC-Penn Valley** - 6:30 a.m. to 10:30 p.m., Monday through Friday, and 6:30 a.m. to 5:00 p.m. on Saturday.

**MCC-Penn Valley/Pioneer** - 7:00 a.m. to 8:00 p.m., Monday through Thursday, 7:00 a.m. to 6:00 p.m. on Friday, and 8:00 a.m. to 4:00 p.m. on Saturday.

## **Security of campus facilities.**

MCC is committed to campus safety and security. Exterior lighting and landscape control is a critical part of that commitment. Department members conduct routine checks of lighting on campus during regular patrol duties. If lights are out or dim, officers will initiate an immediate work request. We encourage community members to report any deficiency in lighting to the MCC Campus Police Control Center at 604-1200. Any community member who has a concern about physical security, especially any locking mechanism deficiency, should contact the Campus Police office on the campus where the concern exists. The Campus Police and facility service departments are available to respond to calls for service regarding unsafe facility conditions or for personal safety and property protection. These conditions also may include unsafe steps or handrails, unsafe roadways on campus, and unsecured equipment.

## Security services.

The Campus Police department's efforts to provide a safe campus environment include the following services:

**Emergency Blue Light Phones** - Two-way call boxes are located strategically around each campus. They allow an individual in need of assistance to speak directly with the Campus Police department or the local 911 dispatch center. Please visit [www.mcckc.edu/publicsafety](http://www.mcckc.edu/publicsafety) and click on the maps for all box locations.

**Campus Escort Program** - the Campus Police department will provide escorts to your vehicle if requested. To request an escort please contact your Campus Police office and an officer will respond to your location.

**AEDs** - An automated external defibrillator (AED) is used to treat victims of sudden cardiac arrest (SCA). MCC makes defibrillators available on its premises so victims can receive early defibrillation, increasing the likelihood of recovery. Since numbers of persons gather at MCC facilities, some undergoing physical exertion such as athletic or recreation center activities, there is a possibility that an individual will experience SCA. MCC serves its community by installing an AED in each of its buildings in the district.

## Education and awareness.

MCC has an ongoing program to provide crime-detering information to students and employees.

Students and employees are reminded to be vigilant and cautious and to exercise common sense not only to protect themselves but also to protect others! **REPORT ANY CRIME YOU OBSERVE IMMEDIATELY.**

Students will be advised of new security procedures as well as crime and sex offense prevention programs through materials distributed during registration and enrollment, bulletin boards placed in buildings throughout the campuses, and student print and electronic newspapers. Employees will be advised during orientation, the MCC newsletter, memoranda, or e-mail.

The Campus Police department publishes general crime prevention flyers that outline many crime prevention tips and strategies. In addition, the department periodically highlights a special topic on its website. Programs regarding crime prevention on campus are scheduled through the campus life and leadership offices.

## Sexual Assault Policy

The Campus Police Department offers sexual assault education and information programs to MCC students and employees upon request. Literature on date rape education, risk reduction, and MCC's responses are available at the Campus Police Department.

If you are a victim of sexual assault at MCC, your first priority should be to get to a place of safety. You should then obtain necessary medical treatment. The Campus Police strongly advocate that the victims of a sexual assault report the incident in a timely manner. Time is a critical factor for evidence collection and preservation. An assault should be reported directly to an MCC Police Officer. Filing a report with an MCC Police Officer will not obligate the victim to prosecute nor will it subject

the victim to scrutiny or judgmental opinions from the officer. Filing a report will:

- Ensure that a victim of sexual assault receives the necessary medical treatment and tests, at no expense to the victim;
- Provide the opportunity for collection of evidence helpful in the prosecution, which cannot be obtained later (ideally a victim of sexual assault should not wash, use the toilet or change clothing prior to a medical/legal examination);
- Ensure the victim has access to free confidential counseling from counselors specifically trained in the area of sexual assault crisis intervention.

When a sexual assault victim contacts the MCC Police Department the Kansas City Police Department, Sex Crimes Unit, will be notified.

MCC Disciplinary Proceedings, as well as special guidelines for cases involving sexual misconduct are detailed in the Code of Student Conduct. The Code of Student Conduct provides, in part that the accused and the victim will each be allowed to choose one person to accompany them throughout the hearing proceeding. Both the victim and the accused will be informed of the outcome of a hearing. A student found guilty of violating MCC's Sexual Misconduct Policy could be criminally prosecuted in state or federal court and may be suspended or expelled from MCC for a first offense. Student victims have the option to change their academic situations after an alleged sexual assault, if such changes are reasonably available.

## Registered Sex Offenders Information.

The federal Campus Sex Crimes Prevention Act, enacted on October 28, 2000, placed in effect October 28, 2002, requires institutions of higher education to issue a statement advising the campus community where law enforcement agency information provided by a State concerning registered sex offenders may be obtained. It also requires sex offenders already required to register in a State to provide notice, as required under State law, of each institution of higher education in that State at which the person is employed, carries on a vocation, volunteers services, or is a student.

Metropolitan Community College campuses are located in both Clay and Jackson Counties in Missouri. A list of the currently registered sex offenders in these counties may be obtained by contacting the Clay and Jackson County Sheriff's departments or by accessing the department websites at:

## Relationship with local law enforcement

The Metropolitan Community College Campus Police Department will provide the best possible atmosphere of collaborative public safety on and around the campuses of Metropolitan Community College and throughout the entire cities of Independence, Kansas City and Lee's Summit, Missouri. The Metropolitan Community College Campus Police Department has established a working relationship with the Independence Missouri Police Department, the Kansas City Missouri Police Department, the Lee's Summit Missouri Police Department, and the Missouri Highway Patrol with the goal of increased public safety in mind.

**Calls for police service** – All calls for police services which are received by the Metropolitan Community College Campus Police Department, and concern incidents which have occurred off the property of Metropolitan Community College and in the jurisdiction of Independence, Kansas City or Lee's Summit, will be referred to the appropriate jurisdiction if required without unnecessary delay.

**Follow-up investigation** – It will be the policy of the Metropolitan Community College Campus Police Department, when appropriate, to notify the Independence Missouri Police Department, Kansas City Missouri Police Department, Lee's Summit Missouri Police Department, or Missouri Highway Patrol when officers are conducting an investigation, and to request that an officer from the relevant jurisdiction assist the investigating officer if such assistance is appropriate.

**Information exchange** – Contemporary law enforcement relies heavily on information. The Metropolitan Community College Campus Police Department recognizes the need for accurate, timely information and the mutual benefits derived from the exchange of such information. The Metropolitan Community College Campus Police Department will provide the Independence Missouri Police Department, Kansas City Missouri Police Department, Lee's Summit Missouri Police Department or the Missouri Highway Patrol with information that may reasonably be expected to impact their city or state.

## Definitions of crimes.

The following are the definitions of crimes used in this report. These are from the F.B.I.'s Uniform Crime Reporting Program.

**Murder/Non-negligent Manslaughter:** Willful (non-negligent) killing of one human being by another.

**Negligent Manslaughter:** The killing of another person through negligence.

**Sex offenses:** A forcible sex offense is any sexual act directed against another person, forcibly and/or against the person's will; or not forcibly or against the person's will where the victim is incapable of giving consent. This includes forcible rape, sodomy, and fondling and sexual assault with an object. A non-forcible sex offense is unlawful, non-forcible sexual intercourse and includes incest and statutory rape.

**Robbery:** Taking or attempted taking of anything of value under confrontational circumstances from the control, custody, or care of another person or persons by force or threat of force or violence and/or by putting the victim in fear of immediate harm.

**Aggravated assault:** An attack by one person upon another wherein the offender uses a weapon or displays it in a threatening manner, or the victim suffers obvious severe or aggravated bodily injury involving apparent broken bones, loss of teeth, possible internal injury, severe lacerations, or loss of consciousness.

**Burglary (breaking and entering):** Unlawful entry into a building or other structure with the intent to commit a felony or a theft. Note: Forced entry is not a required element of the offense so long as the entry is unlawful (trespassing).

**Motor vehicle theft:** Theft or attempted theft of a motor vehicle.

**Arson:** Any willful or malicious burning or attempt to burn with or without intent to defraud, a dwelling house, public building, motor vehicle, or aircraft, personal property of another, etc.

**Hate Crime:** Any crime listed above, and any other crime involving bodily injury, which manifests evidence that the victim was intentionally selected because of the victim's actual or perceived race, gender, religion, sexual orientation, ethnicity, or disability.

**Larceny-Theft:** The unlawful taking, carrying, leading, or riding away of property from the possession or constructive possession of another.

**Simple Assault:** An unlawful physical attack by one person upon another where neither the offender displays a weapon, nor the victim suffers obvious severe or aggravated bodily injury involving apparent broken bones, loss of teeth, possible internal injury, severe laceration, or loss of consciousness.

**Intimidation:** To unlawfully place another person in reasonable fear of bodily harm through the use of threatening words and/or other conduct, but without displaying a weapon or subjecting the victim to actual physical attack.

**Vandalism:** To willfully or maliciously destroy, injure, disfigure, or deface any public or private property, real or personal, without the consent of the owner or person having custody or control by cutting, tearing, breaking, marking, painting, drawing, covering with filth, or any other such means as may be specified by local law.

## Crime Statistics.

The following charts list crimes on MCC campuses and adjacent public property. They also show arrests and disciplinary referrals for liquor law, drug abuse, and weapons possession violations. If any of the reported crimes in the "All Crimes" section is considered to be a hate crime, that information is also reported under the "All Hate Crimes" heading. The "Hate Crimes (By Prejudice)" section further describes reported hate crimes by category of prejudice.

The statistics in this report are gathered by the Campus Police Captains. A daily crime log is maintained on each campus. Campus Police Captains work collaboratively with local police departments and Campus Police authorities to collect crime statistics in a timely manner. Others who may become aware of criminal offenses are encouraged to report these offenses to Campus Police authorities.

# SAFETY TIPS

## Following these tips can help prevent you from becoming a victim.

Stay in well-lit areas. Plan your route and use public sidewalks or walk midway between curbs and buildings away from alleys, entries and bushes. Avoid shortcuts through parks, vacant lots and other deserted places.

When possible, walk in groups – there is safety in numbers.

Scan the area as you approach or leave buildings or parking lots.

Consider carrying a personal safety alarm device.

Always lock the car door upon entering or leaving your vehicle.

Never leave your windows down, even a crack, in your parked car.

Never leave your keys in an unattended car.

Do not hide a key on or in your car.

Never attach a tag with your name and address to a key ring.

Make sure valuables are out of sight or locked in the trunk.

When approaching your vehicle, scan the immediate area. Have your keys in hand and scan the inside of your car before entering.

Don't leave vital information in your car - it provides personal information to a criminal.

Report anyone who behaves suspiciously to Campus Police.

Advise physical plant or Campus Police of any hazards or security concerns.

Follow your instincts – if your intuition tells you there is a risk, act accordingly.

If you believe you are being followed, cross the street, change direction or vary your pace. This might discourage the follower.

If you carry a handbag, keep it close to your body. If your bag is snatched, don't fight.

As a rule, do not stop to give direction or other information to strangers.

If you feel uncomfortable in an elevator, leave at the first chance you have. Don't feel embarrassed or guilty for protecting yourself.

While in class or office, keep personal belongings in view.

Keys should always be kept in your possession. Missing keys should be reported immediately.

Keep your purse either with you or in a locked location.

Do not remove rings to wash your hands – they can be forgotten and/or stolen.

Carry only necessary credit cards and money.

## Notice of Nondiscrimination

This public **“NOTICE of NON-DISCRIMINATION”** is required by several federal laws and regulations including those implementing Title VI, Title VII, Title IX, Americans with Disabilities Act, Section 504 and the Age Discrimination Act. This notice serves to inform all members of the Metropolitan Community College faculty, staff, student body and guests, that Metropolitan Community College prohibits discrimination on the basis of race, color, religion, sex, sexual orientation, age, birth, ancestry, national origin, or disability in admissions; educational programs, services, or activities; and employment. Following are the applicable federal and state Civil Rights laws that prohibit discrimination:

**Title I of the Americans with Disabilities Act of 1990** prohibits employment discrimination against qualified individuals with disabilities by employers with 15 or more employees. The U.S. Equal Employment Opportunity Commission and the Office for Civil Rights are the agencies assigned to enforce Title I of the ADA.

**Title II of the Americans with Disabilities Act of 1990** prohibits disability discrimination by public entities, including public colleges and universities whether or not they receive federal financial assistance. The Office for Civil Rights (U.S. Department of Education) is the law enforcement agency charged with enforcing Title II of the ADA.

**Title VI of the Civil Rights Act of 1964** prohibits discrimination on the basis of race, color, or national origin in any program or activity receiving federal financial assistance. Programs and activities that receive federal financial assistance from the United States Department of Education are covered by Title VI. The Office for Civil Rights (U.S. Department of Education) is the law enforcement agency charged with enforcing Title VI.

**Title VII of the Civil Rights Act of 1964** protects individuals against unlawful employment practices based on their race, color, sex, and national origin. The Civil Rights Act of 1991 significantly extended plaintiffs' rights under Title VII. The U.S. Equal Employment Opportunity Commission is the law enforcement agency charged with enforcing Title VII.

**Title IX of the Education Amendments of 1972** prohibits discrimination on the basis of sex in education programs or activities and extends to employment and admission to institutions that receive

federal financial assistance. The Office for Civil Rights (U.S. Department of Education) is the law enforcement agency charged with enforcing Title IX.

**Age Discrimination Act of 1975** protects people from discrimination based on age in programs or activities receiving federal financial assistance. The Office for Civil Rights (U.S. Department of Education) is the law enforcement agency charged with enforcing the ADA of 1975.

**Age Discrimination in Employment Act of 1967** protects individuals who are 40 years of age or older. The U.S. Equal Employment Opportunity Commission is the law enforcement agency charged with enforcing the ADEA.

**Civil Rights Act of 1991** provides monetary damages in cases of intentional employment discrimination. The U.S. Equal Employment Opportunity Commission is the law enforcement agency charged with enforcing the CRA of 1991.

**Equal Pay Act of 1963** protects men and women who perform substantially equal work in the same establishment from sex-based wage discrimination. The U.S. Equal Employment Opportunity Commission is the law enforcement agency charged with enforcing the EPA.

**Section 504 of the Rehabilitation Act of 1973** protects people from discrimination in admission, employment, treatment, or access based on disability in programs or activities receiving federal financial assistance. The Office for Civil Rights (U.S. Department of Education) is the law enforcement agency charged with enforcing Section 504.

**Executive Order 11246** requires certain government contractors to engage in affirmative action and to not discriminate based on race, sex, or national origin. The Office of Federal Contract Compliance Programs (U.S. Department of Labor) is the agency charged with enforcing EO 11246 and ensuring that federal contractors are in compliance.

## COLLEGE NONDISCRIMINATION STATEMENT:

## **Discrimination and Harassment, Including Sexual Harassment**

It is the policy of the Metropolitan Community College to provide equal opportunity for all enrolled students and applicants for admission to the college, free from discrimination and harassment (including sexual harassment), based on race, color, religion, sex, sexual orientation, national origin, age, and/or disability. This policy applies to discrimination and/or harassment complaints by students for actions occurring on college property or in admissions, program access, student employment of regular student workers and work-study student workers, and treatment in official college programs and activities. This policy applies to any person who has applied to the college for admission or readmission, who is currently enrolled, or who was a student of the college at the time of the alleged discrimination or harassment.

MCC uses the following definition for discrimination and harassment:

1. Discrimination is the denial of opportunity to, or adverse action against, a person because of that person's race, color, religion, sex, sexual orientation, national origin, age, and/or disability. Actions or policies that provide unequal opportunity in education or employment or adversely affect the terms and conditions of a person's education or student employment at the college and which are motivated or based, in whole or in part, upon any of the foregoing categories can constitute discrimination in violation of the college's non-discrimination policy.
2. Harassment is a form of discrimination that occurs when verbal or physical conduct based on an individual's protected status unreasonably interferes with that individual's academic or work performance or creates a hostile educational or work environment for that individual, including affecting his/her personal safety or participation in college-sponsored activities.
  - a. Hostile Environment. Unwelcome conduct by an individual(s) against another individual based upon protected category/status that is sufficiently severe or pervasive that it alters

the conditions of education or student employment and creates an environment that a reasonable person would find intimidating, hostile, or offensive. The determination of whether an environment is hostile must be based on all of the circumstances. These circumstances could include the severity of the conduct, the frequency, and whether it is threatening or offensive.

- b. "Quid Pro Quo" Harassment. Unwelcome sexual advances, requests for sexual favors, and other verbal or physical conduct of a sexual nature when:
  - i. submission to such conduct is made either explicitly or implicitly a term or condition of an individual's employment;
  - ii. submission to or rejection of such conduct by an individual is used as a basis for an employment decision affecting that individual; or
  - iii. such conduct has the purpose or effect of creating a hostile work environment.

## Student Rights Under The Family Educational Rights And Privacy Act (FERPA)

The Family Educational Rights and Privacy Act (FERPA) affords students certain rights with respect to their education records. They are:

1. The right to inspect and review the student's education records within 45 days of the day the College receives a request for access. Students should submit to the Dean of Students or the Office of the Registrar/Enrollment Manager ("College Official") a written request that identifies the record(s) they wish to inspect. The College Official will make arrangements for access and notify the student of the time and place where the records may be inspected. If the records are not maintained by the College Official to whom the request was submitted, that official shall advise the student of the correct official to whom the request should be addressed.
2. The right to request the amendment of the student's education records that the student believes are inaccurate, misleading, or in violation of the student's right to privacy. Students desiring an amendment to their education record should write the College Official responsible for maintaining the record, clearly identify the part of the record they want changed, and specify why it is inaccurate, misleading, or in violation of the student's privacy.
3. The right to a hearing regarding the request for an amendment of the student's education records. If the College decides not to amend the record as requested by the student, the College must notify the student of the decision and advise the student of his or her right to a hearing regarding the request for amendment. Additional information regarding the hearing procedures will be provided to the student when notified of the right to a hearing.
4. The right to prevent the College's disclosure of the student's personally identifiable information from the student's education records in most circumstances. The College must obtain the written consent of a student before disclosing that student's personally identifiable information contained in the student's education records, except to the extent that FERPA authorizes disclosure without consent. Where required, a student's consent must specify the records to be disclosed, the purpose of the disclosure, and the party or class of parties to whom disclosure may be made. FERPA contains the following exceptions allowing a College to disclose a student's personally identifiable information:
  - a) Disclosure to school officials with legitimate educational interests is permitted without a student's written consent. A school official is a person employed by the College in

Discrimination and harassment, including sexual harassment, will not be tolerated either in the classroom or in the workplace. an administrative, supervisory, academic or research, or support staff position (including law enforcement unit personnel and health staff); a person or company with whom the College has contracted institutional services or functions that the College would otherwise use employees to perform (such as an attorney, auditor, or collection agent); a person serving on the Board of Trustees; or a student serving on an official committee, such as a disciplinary or grievance committee, or assisting another school official in performing his or her tasks. A school official has a legitimate educational interest if the official needs to review an education record in order to fulfill his or her professional responsibility. A school official must be under the direct control of the institution with respect to the use and maintenance of information from education records.

b) Disclosures to parents are permitted in three situations. First, disclosure of a student's personally identifiable information to parents is permitted absent a student's written consent in the event of a health or safety emergency. The College may disclose education records in an emergency if the College determines that there is an articulable and significant threat to the health or safety of the student or other individuals. Second, disclosure of a student's personally identifiable information is permitted to parents of the student if the student is a dependent pursuant to Section 152 of the Internal Revenue Code of 1986 and notice is given to the student that a parent has requested such information. Third, disclosure of a student's personally identifiable information to parents is permitted without the student's written consent if the student is under 21 and has violated a law or College rule or policy governing alcohol or controlled substance consumption.

5. The right to opt out of the disclosure of directory information. Pursuant to FERPA, the College has classified certain personally identifiable information as directory information. Metropolitan Community College defines directory information as the student's name, address, telephone number, e-mail address, photos, date of birth, place of birth, class, major field of study, dates of attendance, full time/part time status, degrees, honors, and awards received, participation in officially recognized activities and sports, physical traits of athletes, and the most recent previous educational institution attended by the student. Students who wish to restrict the release of directory information must submit the appropriate form to the Office of the Registrar/Enrollment Manager during the first week of each academic term. This form can be found on the College's website, at the Dean of Students' Office or at the Office of the Registrar/Enrollment Manager. Upon receipt of such request the Office of the Registrar/Enrollment Manager will designate that the student's directory information is confidential and not to be released outside the College except to individuals, institutions, agencies and organizations authorized in the Act. The College

will honor all requests to withhold any of the categories of directory information listed above but cannot assume any responsibility to contact the student for subsequent permission to release information. Nondisclosure will be enforced until the information is subsequently released by the student. A student may not, however, opt-out of disclosure of the student's name, institutional e-mail address, or electronic identifier in the student's classroom. Regardless of the effect on the student, the College assumes no liability for honoring the request of the student to restrict the disclosure of directory information.

6. The right to file a complaint with the U.S. Department of Education concerning alleged failures by Metropolitan Community College to comply with the requirements of FERPA. The name and address of the Office that administers FERPA is:

## Copyright Infringement

Copyright is a form of protection provided by the laws of the United States to the authors of "original works of authorship," including literary, dramatic, musical, artistic, and certain other intellectual works. Metropolitan Community College complies fully with all of the provisions of the U.S. Copyright Law (17 U.S.C.) and its amendments. MCC supports the Fair Use section of the Copyright Law (17 U.S.C. 107) which permits and protects citizens' rights to reproduce and make other uses of copyrighted works for the purposes of teaching, scholarships and research.

Copyright infringement is the act of exercising, without permission or legal authority, one or more of the exclusive rights granted to the copyright owner under section 106 of the Copyright Act (Title 17 of the United States Code). These rights include the right to reproduce or distribute a copyrighted work. In the file-sharing context, downloading or uploading substantial parts of a copyrighted work without authority constitutes an infringement.

Penalties for copyright infringement include civil and criminal penalties. In general, anyone found liable for civil copyright infringement may be ordered to pay either actual damages or "statutory" damages affixed at not less than \$750 and not more than \$30,000 per work infringed. For "willful" infringement, a court may award up to \$150,000 per work infringed. A court can, in its discretion, also assess costs and attorneys' fees. For details, see Title 17, United States Code, Sections 504, 505.

Willful copyright infringement can also result in criminal penalties, including imprisonment of up to five years and fines of up to \$250,000 per offense. ## Tobacco-Free MCC

Metropolitan Community College is committed to providing a safe and healthy environment for all students, employees, contractors, and visitors. As a result of this commitment, the use, advertising, or sponsorship of tobacco and tobacco substitute products, excluding cessation products, on all campus premises, leased property, and college-owned vehicles is prohibited, with no exceptions. This policy applies to all students, employees, tenants, subtenants, contractors, and visitors.

### I. Definitions

A. Smoking means inhaling, exhaling, burning, carrying, or possessing any lighted tobacco product, including cigarettes, cigars, pipe tobacco, and any other lighted tobacco products.

B. Tobacco use means the personal use of any tobacco product, whether intended to be lighted or not, which shall include smoking, as defined above, the use of an electronic cigarette, or any other device intended to simulate smoking and the use of smokeless tobacco, including snuff, chewing tobacco, smokeless pouches, any other form of loose-leaf, smokeless tobacco, and the use of unlit cigarettes, cigars, and pipe tobacco.

### II. Advertising

With the exception of advertising in a newspaper, magazine, or similar publication that is not produced by the college, no tobacco-related advertising or sponsorship shall be permitted on college property or at college-sponsored events. No tobacco-related advertising or sponsorship shall appear in any publications produced by the college or by a club or association authorized by the college. For purposes of this policy, the term tobacco-related applies to the use of a brand or corporate name, trademark, logo, symbol, motto, or selling message identifiable with any brand of tobacco products or company which manufactures tobacco products.

## Complaint Notification

Students who have complaints in the following categories do not need to exhaust the internal complaint procedure.

- Complaints of criminal misconduct may be filed directly with local law enforcement authority.
- Complaints related to violations of federal law may be filed directly with the federal agency overseeing the law (see Notice of Nondiscrimination and FERPA Policy).

Students who have other complaints with MCC must first exhaust MCC's internal complaint process. Students who have exhausted the internal complaint process may submit their complaints as follows:

- All complaints may be lodged with the Missouri Department of Higher Education (MDHE) only **after exhaustion of all informal and formal institutional processes**. MDHE requires as a prerequisite to filing any formal complaint that the student verify exhaustion of all informal and formal remedies. A student must first call MDHE at (573) 526-1577 to indicate their desire to file a complaint. At that time the MDHE will ascertain whether the issue can be resolved through informal means and also determine whether the administrative process available within MCC has been exhausted. If after screening the applicant still desires to initiate a formal complaint, the MDHE will send complainant the form to fill out and return for that purpose.

## Equity in Athletics

Metropolitan Community College annually submits information to the Department of Education in response to the Equity in Athletics Disclosure Act (EADA). This information helps prospective student-athletes make decisions about their potential or continued enrollment in a postsecondary institution. The information can help to assess an institution's commitment to and progress toward gender equity in its intercollegiate athletic program. MCC has athletic programs at its Blue River, Longview, Maple Woods, and Penn Valley campuses. # DRUG-FREE WORKPLACE, CAMPUS AND COMMUNITY

---

MCC is committed to a safe, secure, healthful, drug-free work, campus, and community environment, and has adopted the Drug-Free Schools and Communities Act and Drug-Free Workplace Act standards as part of its own policies. Employees are expected and required to report to work and participate in district activities, and students are expected and required to attend classes and participate in district activities, in appropriate mental and physical condition.

All applicable alcohol and drug regulations, including Federal and State underage drinking laws, are enforced. The unlawful possession, use, and/or sale of alcoholic beverages and illegal drugs is specifically prohibited and violations carry substantial sanctions. Violators are subject to both MCC's sanctions and criminal sanctions. MCC sanctions can result in disciplinary action up to and including expulsion for students and discharge for employees (see MCC Board Policy and District Regulation 3.30060). Federal penalties for possession and trafficking of controlled substances are listed on the following pages.

Each campus provides educational information on drug and alcohol abuse through the distribution of brochures and through programming scheduled through the student activities offices. Students with alcohol or drug-related problems are encouraged to utilize the services of private and community agencies. The counseling offices on each campus can provide appropriate referral information. Employees with alcohol or drug-related problems are encouraged to utilize the services of the district employee assistance program.

There are serious health risks associated with the use of illicit drugs and the abuse of alcohol. These can include addiction or dependency, physical infirmities and trauma, mental and emotional disorders, and marked changes in behavior. The following charts list the uses and effects of controlled substances, including associated health risks.

## Alcohol Effects

Alcohol consumption causes a number of marked changes in behavior. Even low doses significantly impair the judgment and coordination required to drive a car safely, increasing the likelihood that the driver will be involved in an accident. Low to moderate doses of alcohol also increase the incidence of a variety of aggressive acts, including spouse and child abuse. Moderate to high doses of alcohol cause marked impairments in higher mental functions, severely altering a person's ability to learn and remember information. Very high doses cause respiratory depression and death. If combined with other depressants of the central nervous system, much lower doses will produce the effects just described.

Repeated use of alcohol can lead to dependence. Sudden cessation of alcohol intake is likely to produce withdrawal symptoms, including severe anxiety, tremors, hallucinations, and convulsions. Alcohol withdrawal can be life threatening. Long-term consumption of large quantities of alcohol, particularly when combined with poor nutrition, can also lead to permanent damage to vital organs such as the brain and the liver.

Mothers who drink alcohol during pregnancy may give birth to infants with fetal alcohol syndrome. These infants have irreversible physical abnormalities and mental retardation. In addition, research indicated that children of alcoholic parents are at greater risk than other youngsters of becoming alcoholics.

## Federal Penalties and Sanctions for Illegal Possession of a Controlled Substance

### 21 U.S.C. 844(a)

1st conviction: Up to 1 year imprisonment and fined at least \$1,000 but not more than \$100,000, or both.

After 1 prior drug conviction: At least 15 days in prison, not to exceed 2 years and fined at least \$2,500 but not more than \$250,000, or both.

After 2 or more prior drug convictions: At least 90 days in prison, not to exceed 3 years and fined at least \$5,000 but not more than \$250,000 or both.

Special sentencing provisions for possession of crack cocaine: Mandatory at least 5 years in prison, not to exceed 20 years and fined up to \$250,000, or both, if:

- (a) 1st conviction and the amount of crack possessed exceeds 5 grams.
- (b) 2nd crack conviction and the amount of crack possessed exceeds 3 grams.
- (c) 3rd or subsequent crack conviction and the amount of crack possessed exceeds 1 gram.

### 21 U.S.C. 853(a)(2) and 881(a)(7)

Forfeiture of personal and real property used to possess or to

facilitate possession of a controlled substance if that offense is punishable by more than 1 year imprisonment. (See special sentencing provisions re: crack)

### 21 U.S.C. 881(a)(4)

Forfeiture of vehicles, boats, aircraft or any other conveyance used to transport or conceal a controlled substance.

### 21 U.S.C. 844(a)

Civil fine of up to \$10,000 (pending adoption of final regulations).

### 21 U.S.C. 853(a)

Denial of Federal benefits, such as student loans, grants, contracts, and professional and commercial licenses, up to 1 year for first offense, up to 5 years for second and subsequent offenses.

### 18 U.S.C. 922(g)

Ineligible to receive or purchase a firearm.

### Miscellaneous

Revocation of certain Federal licenses and benefits, e.g. pilot licenses, public housing tenancy, etc., are vested within the authorities of individual Federal agencies.
