**SEARCH UNDERWAY
FOR METROPOLITAN COMMUNITY COLLEGE TRUSTEES
SUBDISTRICT 4**

The Junior College District of Metropolitan Kansas City, Missouri (Metropolitan Community College) is seeking applicants to fill a vacancy on the board of trustees; due to resignation of a trustee upon his taking a governmental appointment.

The vacancy is in subdistrict 4 (see walking description and map of subdistrict 4).

A trustee for subdistrict 4 will be appointed by the remaining members of the board and will serve until the next regularly scheduled election in April of 2020 when a trustee shall be elected for the unexpired term.

Qualifications, Process and Criteria

The following qualifications and process shall apply for selection of the new trustee for subdistrict 4:

- Candidates for the office of trustee shall be citizens of the United States, at least twenty-one years of age, who have been voters of the subdistrict for which each is recommended or applies for at least one whole year next preceding October 31, 2019.
- No person shall qualify as a candidate who has been found guilty of or pled guilty to a felony under the federal laws of the United States of America or to a felony under the laws of this state or an offense committed in another state that would be considered a felony in this state.
- No person shall qualify as a candidate if such person is delinquent in the payment of any state income taxes, personal property taxes, municipal taxes, real property taxes on the place of residence, as stated on the declaration of candidacy, or if the person is a past or present corporate officer of any fee office that owes any taxes to the state.
- On or before 4:00 p.m. on October 31, 2019, all candidates for the office of trustee, who wish to be considered by the board, shall complete and file an affidavit with the Missouri Department of Revenue and include a copy of the completed affidavit along with the declaration of candidacy required to be completed and delivered to the secretary of the board of trustees, Cynthia K. Johnson (see below). Such affidavit shall be on Missouri Department of Revenue Form 5120 attesting to tax payments and bonding requirements <http://dor.mo.gov/forms/5120.pdf>

- The personal financial disclosure statement which is required to be filed with the Missouri Ethics Commission shall be completed and timely filed and a copy of the completed Missouri Ethics Commission form delivered along with the declaration of candidacy required to be completed and delivered to the secretary of the board of trustees, Cynthia K. Johnson (see below).
- On or before 4:00 p.m. October 31, 2019, all candidates for the office of trustee, who wish to be considered by the board, shall complete and file their declarations of candidacy with the secretary of the board of trustees, Cynthia K. Johnson, Metropolitan Community College Administrative Center, 3200 Broadway, Kansas City, Missouri 64111 in this form (see attachment). The candidate's driver license is required to be presented for copy with such declaration.
- Submissions shall also include a one to two-page letter stating the reasons for seeking the trusteeship and a biography or resume stating the candidate's qualifications for the trusteeship.

The board will also consider the following criteria in selecting the new trustees:

- Respected leader active in community life
- Educational philosophy compatible with the MCC mission
- Experience in education or a familiarity with the educational needs of the subdistrict
- Willingness to serve as an "ambassador" for the entire MCC district, not just subdistrict interests
- Strong belief in quality community college education, as evidenced by past support
- Ability to commit sufficient time
- Ability to offer a talent that rounds out the strength and variety needed by the board to fulfill its responsibilities
- An understanding and acceptance of the role of a community college trustee

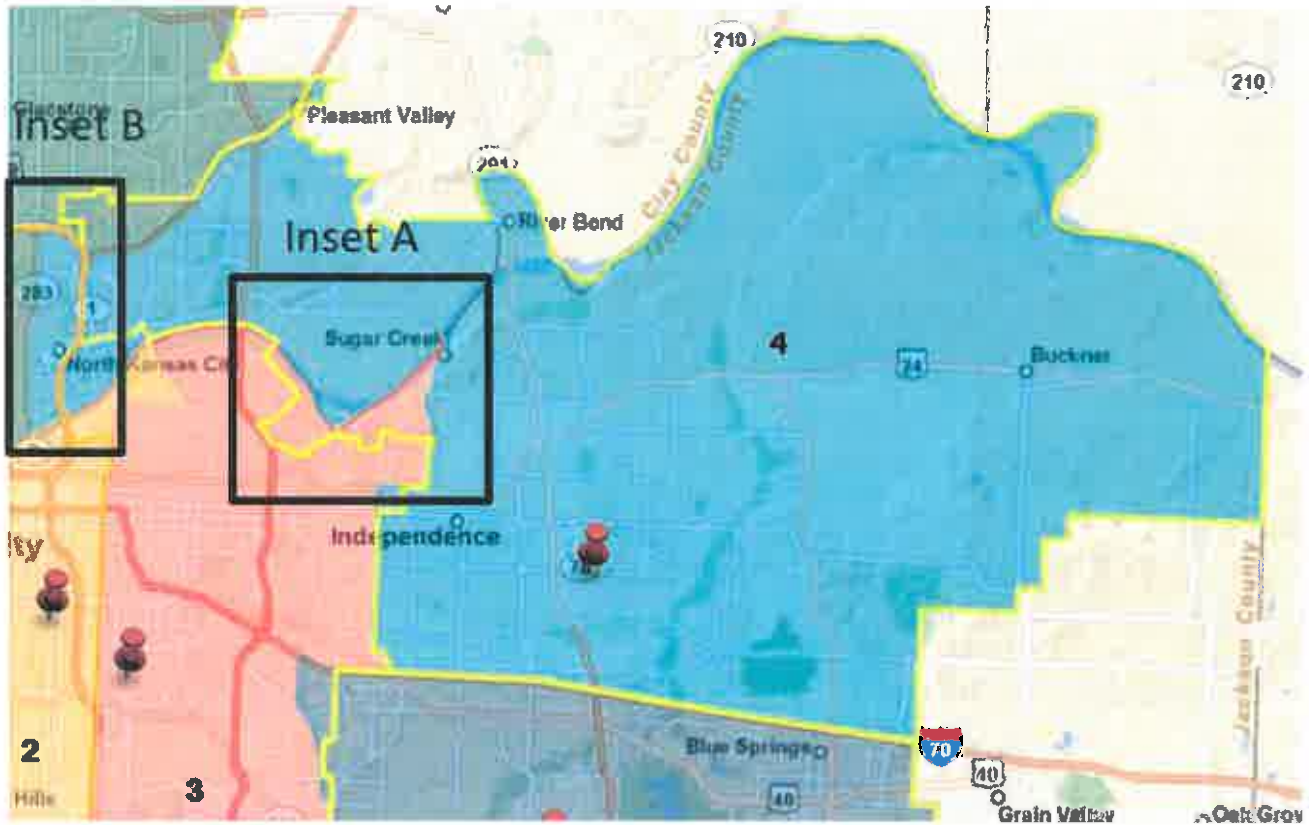
Subdistrict 4

From the intersection of Chouteau Trfwy and the Jackson/Clay County Line then north on Chouteau Trfwy to Armour Rd, then west on Armour Rd to I-29, then north on I-29 to Davidson Rd, then northeast on Davidson Rd to Highland Rd, then North on Highland Rd to US 69 Hwy, then west on US 69 Hwy to Troost Ave, then north on Troost Ave to 52nd Ter, then east on 52nd Ter to Garfield Ave, then north on Garfield Ave to 54th St, then east on 54th street and continuing east on 53rd St to M-1 Hwy (Antioch Rd), then south on M-1 Hwy (Antioch Rd) to US 69 Hwy, then east on US 69 Hwy to I-35, then northeast on I-35 to where North Kansas City School District crosses I-35 at its northern point, then follow the North Kansas City School District boundary east, south, then east to the Clay County Line, (which is the centerline of the old River Channel), then continue east on the Clay County Line to the northeast corner of Jackson County, Missouri, then south on the Jackson County, Missouri Line to the Fort Osage School District boundary, then west, southwest, west along the Fort Osage School District boundary to the northeast boundary of the Blue Springs School District Boundary, then south along the Blue Springs School District Boundary to I-70, then west on I-70 to Blue Ridge Blvd, then northwest on Blue Ridge Blvd to Sterling Ave, then north on Sterling Ave to Truman Rd, then east on Truman Rd to Forest Ave, then north on Forest Ave to US 24 Hwy, then east on US 24 Hwy to River Blvd, then north on River Blvd to Silver Ln, then west on Silver Ln to Vermont St, then north on Vermont St to Putnam St, then west on Putnam St to Kansas City Southern Railway, then north along Kansas City Southern Railway to the Missouri River and the Jackson/Clay County Line, then west along the Jackson/Clay County Line to Chouteau Trfwy and the point of beginning.
